## Action Items

### 12. AQUATIC PARK IMPROVEMENT PROGRAM

Gurdziel motioned to accept the staff report and adopt Preferred Alternative Model 4b with the condition that storm water from Potter and Strawberry storm drains be prevented from entering the lagoons. No action.

Stephens moved to accept the above recommendations; to include the seven additional recommendations proposed in distributed hand-out (attached) and; to include all in CEQA. No action.

It was M/S/C (Huang/Ferrera) to accept staff report as clarified below and adopt Preferred Alternative Model 4b with the amendment that storm water be prevented from entering the lagoons from Potter and Strawberry culverts. The 7 recommendations from Commissioner Stevens (attached) be forwarded for review during project scoping. Clarifications: include reference to tide levels in discussion of storm water runoff entering the lagoons; fencing may be installed on an as-needed basis, and is not a project "given;" soil removed will be utilized onsite if possible (meets safety/toxic concerns) Ayes: Paskowitz, Ferrara, Stephens, Huang, Chavez, Gurdziel; Noes: Becker; Absent: Porter, Gross

It should be noted that Commissioner Becker supported Model 4b without the amendment to exclude storm water.
